

UNITED AIRLINES/UNITED EXPRESS FLIGHT NUMBER RANGES EFFECTIVE SEPTEMBER 6, 2017¹

This chart contains current flight number ranges assigned to all United mainline and United Express flights. This chart also displays the UA and United Express Carriers' policies governing the acceptance of UN3373 and dry ice in QuickPak domestic small package shipments and Express Carriers' acceptance of PetSafe shipments.

Flight numbers 1-1299, 1400-2124 and 2380-2429 represent United Airlines mainline service. All United Cargo products may be transported on these flights.

⁴ Live animals as PetSafe are accepted on ExpressJet if the flight is less than three hours duration and operated with Embraer 135 or Embraer 145 aircraft. Please call United PetSafe at 1-800-575-3335 to verify that a specific ExpressJet flight accepts PetSafe.
