

United Cargo U.S. and Puerto Rico Accessorial Fees Effective July 1, 2019

Terms and conditions applicable to fees below:

- Charges should be inserted on AWB in the “Other charges due carrier” field using the codes shown below
- These fees are for reference only and are subject to change
- All fees are shown in U.S. Dollars

AW	AWB fee – Assessed when United is requested to amend/change the destination on the AWB after departure of the shipment from the airport of origin	For destination changes: INTL AWB: \$125 Domestic AWB: \$50
BR	Bank release – Assessed when United is required to obtain written bank release prior to releasing shipment to consignee	\$10 per release
CC	Manual input of HAWB data – Assessed when United provides manual input of HAWB information if required to meet local Customs requirements. <i>(Note: For inbound U.S. shipments, see “TACT Rules United Airlines 8.3” on unitedcargo.com)</i>	\$10 per HAWB for outbound U.S. shipments
